

GUIDELINES ON PLAGIARISM SANCTIONS

Introduction

Plagiarism is defined as the "use, without giving reasonable and appropriate credit to or acknowledging the author or source, of another person's original work, whether such work is made up of code, formulas, ideas, language, research, strategies, writing or other form" ¹.

The IMM Graduate School of Marketing (IMM GSM) divides plagiarism into three categories namely:-

- 1. Plagiarism from **textual / internet sources** such as:
 - a. Incorrect Harvard Referencing.
 - b. Presenting someone else's work as your own The core content is clearly similar to that of another source
 - c. Paraphrasing someone else's work and presenting it as your own The core content is clearly similar to that of another source, where the wording was changed in an attempt to make it seem original.
- 2. Plagiarism from another student or group also referred to as syndication
 - a. Voluntary Syndication A student / group submits work that is similar / identical to another student / group, or work that contains selected passages that are identical, but this is due to the student / group having worked together and failed to present the work as their own.
 - b. Involuntary Syndication A student / group having appropriated the work from another student / group without the other student / group knowledge or collusion

Guidelines

- When this document refers to the student losing 20% of the assignment mark, or 50% of the assignment mark, it means that if the original assignment was awarded 60%; then the student assignment will be reduced to 48% (less 20% rule), and reduced to 30% (less 50% rule).
- The total number of offences are calculated as the number of offences during the full period of registration with the IMM GSM – regardless of the programme or year of study.
- Refunds The only fees which will be refunded are any fees in excess of the fees paid for the semester during which a student is suspended or disenrolled.
