ENTRANCE REQUIREMENTS FOR FOREIGN QUALIFICATIONS

Certificate

Admission criteria

Entrance requirements for prospective students who have qualified with a school leaving certificate which has not been issued by an approved authority in South Africa, such as UMALUSI:

Students with GCE:

- 5 x "O" or "A" levels with a pass of A/B/C/D or 1/2/3/4
- English Language or Literature in English must be one of the subjects
- A CV detailing work-related experience must be submitted by students over the age of 23 years plus "O" or "A" levels for Recognition of Prior Learning (RPL) applications

Ghana students with West African Senior School Certificate Examination (WASSCE) or

Senior Secondary School Certificate Examination (SSSCE):

- Credit passes A1 - C6 in WASSCE in 5 subjects including English Language or
- Credit passes A - D in SSSCE in 5 subjects including English Language
- A CV detailing work-related experience must be submitted by students over the age of 23 years plus school leaving results for RPL applications

Admission Criteria

Entrance requirements for prospective students who have qualified with a school leaving certificate which has not been issued by an approved authority in South Africa such as UMALUSI

All countries with "O" level or GCE:

- 5 x "O" levels with a pass of A/B/C or 1/2/3
- English Language or Literature in English must be one of the subjects
- A CV detailing work-related experience must be submitted by students over the age of 23 years plus "O" or "A" levels for RPL applications

Ghana students with West African Senior School Certificate Examination (WASSCE) or

Senior Secondary School Certificate Examination (SSSCE):

- Credit passes A1 - C6 in WASSCE in 5 subjects comprising 3 core subjects, including English Language and Mathematics plus 2 elective subjects or
- Credit passes A - D in SSSCE in 5 subjects comprising 3 core subjects, including English Language and Mathematics plus 2 elective subjects
- A CV detailing work-related experience must be submitted for prospective students over the age of 23 years plus school leaving results for RPL applications

Admission Criteria

Entrance requirements for prospective students who have qualified with a school leaving certificate which has not been issued by an approved authority in South Africa such as UMALUSI

All countries with A-level or HIGCSE:

- At least 5 "O" level passes with a pass of A/B/C or 1/2/3
- At least 2 x "A" levels with a pass of A/B/C/D/E or 1/2/3/4/5
- English Language or Literature in English must be one of the subjects
- Mathematics must be one of the subjects
- A minimum of two of the following subjects must be included:
Accounting | Agricultural Science | Business Studies | Biology | Science | Consumer Science | General Science | Economics | Engineering | Graphics & Design | Physiology
Geography | History | Information Technology | Life Sciences | Visual Arts

Ghana students with West African Senior School Certificate Examination (WASSCE) or

Senior Secondary School Certificate Examination (SSSCE):

- 2 approved West Africa Advanced level subjects (A - E) as well as 3 approved West African Ordinary subjects (1 - 6)
- Credit passes (A1 - C6) in WASSCE in 5 subjects plus 3 South African Higher Grade subject equivalents and completion of the first year of a four year bachelor's degree programme from a West African University
- Credit passes (A - D) in SSSCE in 5 subjects plus 3 South African Higher Grade subject equivalents and completion of the first year of a four year bachelor's degree programme from a West African University.
- 5 National Examination Council (NECO) subjects and 3 South African Higher Grade subject equivalents and completion of the first year of a four year bachelor's degree programme from a West African University.
- 5 National Examination Council (NECO) subjects and completion of a 3 year Polytechnic Diploma
- English and Mathematics must be 2 of the subjects
- A minimum of two of the following Higher Grade subjects must be included:
Accounting | Agricultural Science | Business Studies | Biology | Science | Consumer Science | General Science | Economics | Engineering | Graphics & Design | Physiology
Geography | History | Information Technology | Life Sciences | Visual Arts

All other qualifications must be evaluated by HESA.
